All spots will be limited to 10x10 spaces. It is up to the vendor to provide everything you will need to sell your products and services, including tent and tables.

After we receive your application our committee will review it and send correspondence letting you know if you have been accepted or not. If accepted you will be sent an invoice with instructions on how to send payment or pay online. Once we have received your payment we will assign you to a spot.

All Vendors will present themselves, products, and food in a respectful manor to suit a family friendly event and in ordinance with Grays Harbor health department codes.

We will be finalizing the map 2 weeks before the event and sending it out to all vendors with a key to show who is in which spot. If you do not get your application in before the map is generated we will give you your assigned number on the day of the event.

There will be a vendor coordinator present during set up and take down to help with any questions.

RELEASE OF LIABILITY AND HOLD HARMLESS AGREEMENT

The undersigned, in consideration of being allowed entry and participation in the Founders' Day Parade, does hereby release, hold harmless, and agree to fully indemnify Aberdeen Founders' Day Committee and City of Aberdeen and their respective members, officers, boards of directors, agents, employees, volunteers, and all other representatives, from any and all claims, causes of action, damages, injuries, or losses, of any kind whatsoever, including attorney fees and costs of suit, that may be incurred as a direct or proximate result of the undersigned's entry and/or participation in said parade or related events, including, but not limited to, those which may arise from the errors or omissions, or intentional, reckless, or negligent acts of either party, or any third party, including Acts of God or other natural forces.

The undersigned, by affixing his/her signature hereto, acknowledges and states that he/she is of legal age, is mentally competent to enter into this agreement, has read and does understand the legal consequences of this agreement, and that he/she has legal authority to represent the individuals and/or organizations listed below as seeking to enter and participate in said event.

The Founders' Day Committee and City of Aberdeen hold the right to refuse any registrations. The Founders' Day Committee and City of Aberdeen hold the right to refuse any vendor who violates this contract, city code, or Washington State Health department code will be asked to leave, and will forfeit their vendor fee.

Food Vendors:

To protect the health and safety of our community we are requiring that you provide approval with the Grays Harbor Health Department or you can be asked to leave, and will forfeit fee. Please email or mail a copy of your approval to the above addresses before June 19, 2020. You must have your approval letter at your booth during your set up and event times. It is up to the Vendor to read and follow all Grays Harbor Health Department regulations for food handling. If you do not follow the regulations you can be asked to leave by the Grays Harbor Health inspector or Founders' Day Committee.
